In accordance with the provisions of Article 19 of Regulation (EU) no. 596/2014 of the European Parliament and of the Council as of April 16<sup>th</sup>, 2014 on market abuse (Regulation on market abuse) and repealing Directive 2003/6/EC of the European Parliament and of the Council and Commission Directive 2003/124/ EC, 2003/125/EC and 2004/72 / EC and Article 2 of Commission Implementing Regulation (EU) 2016/523 of March 10<sup>th</sup>, 2016 on setting implementing technical standards regarding the format and template for the notification and publication of transactions by managers in accordance with Regulation (EU) ) no. 596/2014 of the European Parliament and the Council, we hereby inform you that we have received a notification about the transaction of a closely related person of the manager in Span d.d. ("Company").

The transaction in question occurred due to disposal of 3,762 shares of the Company (symbol SPAN-R-A) by the affiliated company Ekobit d.o.o., Koturaška cesta 47, OIB: 69609657776, in which Mr. Dragan Marković is the President of the Management Board and also a member of the Issuer's Management Board. The disposal was made on March 15<sup>th</sup>, 2024, outside the regulated market, for the purpose of fulfilling a Share Allocation Plan awarding employees of Ekobit and in accordance with the purchase and sale agreement of business shares of the company Ekobit d.o.o.
